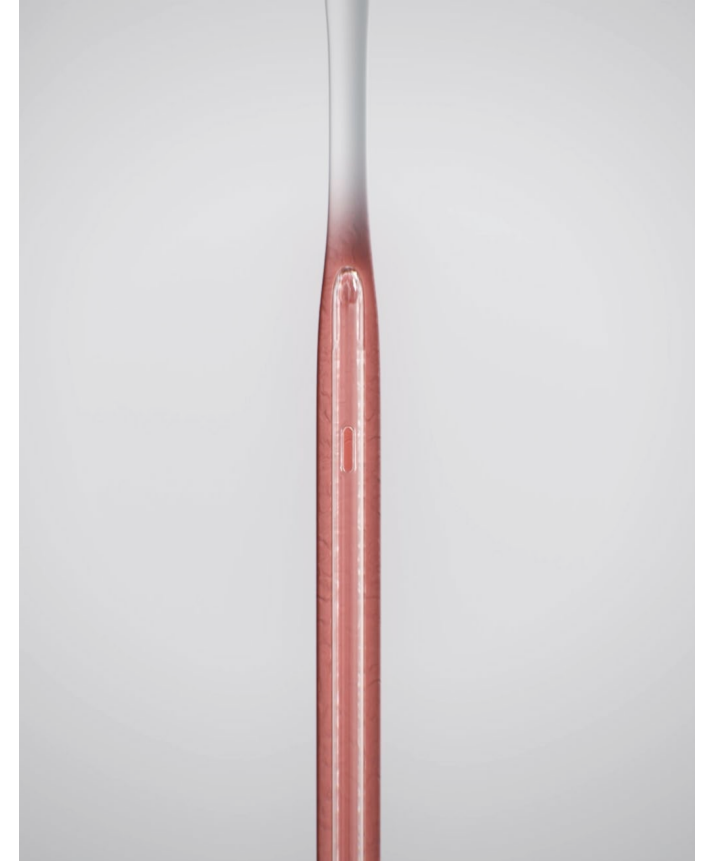

New HCPCS codes for hydrophilic coated intermittent catheters

Intermittent catheters (ICs) 101:

- Single-use¹ medical device that is inserted through the urethra to drain the bladder 4-6 times daily² (~1,825 per year)
- Covered by Medicare under the “prosthetic device benefit” category³
- Utilized by individuals with permanent urinary retention and/or permanent urinary incontinence, including those with neurogenic lower urinary tract dysfunction (NLUTD)
 - Spinal cord injury, spina bifida, multiple sclerosis, Parkinson’s, late-stage diabetes, stroke, cancer, enlarged prostate (BPH), prolapse⁴
 - Urinary tract infections (UTI) are a major burden for individuals with NLUTD⁵
- Catheter choice is complex and multi-factorial⁶

AAHomecare's Intermittent Catheter Coding Reform Coalition (ICCRC) addressed IC HCPCS challenges

- Currently, 1,300 products¹ constrained into 3 HCPCS codes, meaning:
 - Not enough product differentiation
 - Does not accurately demonstrate the advancements in catheter innovation
- A multi-stakeholder coalition led by AAHomecare, focused on protecting access to catheters, applied for new HCPCS codes to recognize various catheter technologies in July 2022

- CMS published a final decision in August 2024, revising current codes, effective January 1, 2026

CMS created 3 new and modified 2 HCPCS codes to distinguish hydrophilic coating technology effective January 1, 2026

Current coding

A4351 Straight tip, with or without coating (teflon, silicone, silicone elastomer, or hydrophilic, etc.)

A4352 Coude tip, with or without coating (teflon, silicone, silicone elastomer, or hydrophilic, etc.)

A4353
Catheter with insertion supplies

New IC code set effective Jan 1, 2026¹

A4351 – Straight tip, with or without coating (teflon, silicone, or ~~hydrophilic~~, silicone elastomer, etc.), each

+

A4295 – Straight tip, hydrophilic coating, each

A4352 – Coude tip, with or without coating (teflon, silicone, or ~~hydrophilic~~, silicone elastomer, etc.), each

+

A4296 – Coude tip, hydrophilic coating, each

A4353 – Intermittent catheter with insertion supplies

CMS is bound by continuity of pricing regulation, therefore Medicare reimbursement rates for new codes are cross-walked

Regulatory requirement prohibits CMS from changing reimbursement rates for the new codes

“When there is a single code that describes two or more distinct complete items (for example, two different but related or similar items), and separate codes are subsequently established for each item, the fee schedule amounts that applied to the single code continue to apply to each of the items described by the new codes.”

Importance of internal and payor education

Action is required to implement new codes with payors and to secure supportive reimbursement with commercial payors

- **Implement new HCPCS codes with payors** to avoid disruption to patient access
 - Ensure ongoing access to medically necessary hydrophilic coated ICs
 - Support access for members with multiple health plans or who have Medicare as primary
 - Reduce financial and administrative burden for cross-over claims
- **Obtain supportive reimbursement** for hydrophilic catheters
 - Review contracts and current reimbursement rates
 - Discuss 'Carve-Out opportunities' for A4295, A4296 and A4297

- ✓ Implement 3 new HCPCS codes (A4295, A4296, A4297)
- ✓ Revise the definitions of A4351 and A4352 (remove hydrophilic)

New HCPCS Codes for Intermittent Catheters, Effective January 1, 2026
Relevant

Intermittent catheters (ICs) are covered by Medicare under the "prosthetic device" benefit category which "must be all or part of an internal body organ". Catheters with the example, individuals with Spina Bifida, large prostate hypertrophy, bladder cancer, diabetes, spinal cord injury, Multiple Sclerosis, Parkinson's Disease, and other conditions that affect the bladder, including and not limited to the example, catheters with innovative features like hydrophilic coating technology. Currently, more than 1,200 intermittent catheter products are described by only three HCPCS codes with little to no product differentiation.

Action Requested prior to 1/1/2026

For a successful implementation of the new and revised HCPCS codes, we request that payors:

- Incorporate the new HCPCS codes and code descriptions into your system(s); and
- Ensure reimbursement allows access to the hydrophilic technology (A4255, A4256 & A4257).

The Change

On August 18, 2024, The Centers for Medicare and Medicaid Services (CMS) announced a decision to modify the existing HCPCS codes and to create three new HCPCS codes to distinguish hydrophilic coating technology within the intermittent catheter product category. This decision not only recognizes the clinical benefits of hydrophilic coating technology but will also support access and other innovation.

Affected Programs: Medicaid, Children's Special Health Care Services (CSHCS), Healthy Michigan Plan

Distribution: Medical Suppliers, Hospitals, Practitioners, Medicaid Health Plans, Integrated Care Organizations

Policy Summary: This policy changes coverage criteria for intermittent urinary catheters specific to hydrophilic-coated intermittent catheters.

Purpose: To implement new hydrophilic intermittent catheter codes effective January 1, 2026, and align coverage criteria with other payers.

Prior Authorization Requirements

Hydrophilic-coated intermittent catheters will no longer require prior authorization if the standards of coverage and documentation requirements are met. Prior authorization is required for medical need beyond the standards of coverage and for quantities above established program limits.

Internal education for DME providers is crucial and will help to ensure continued access to hydrophilic catheters

- Reviewing the catheter HCPCS changes with your team(s)
- Discussing the changes with your referral sources and clinicians
- Identifying hydro and non-hydro users
- Updating/obtaining new prescriptions
- Aligning pricing tables and other systems/processes
- Educating catheter users

Medicare coverage criteria: Proposed urological supplies local coverage determination (LCD)

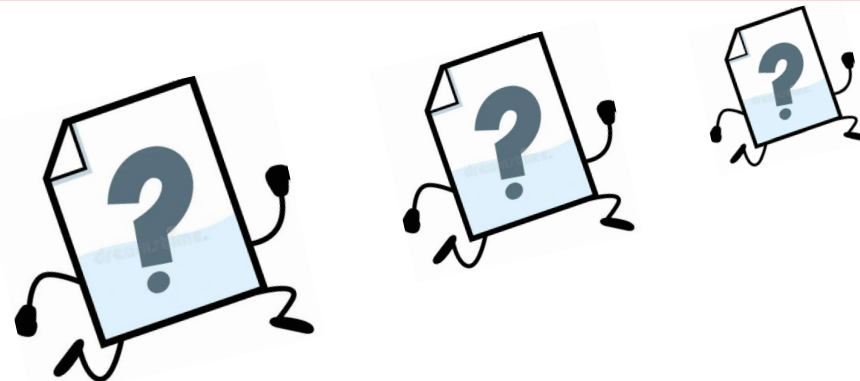
Medicare will either update the existing Urological LCD or publish a new one

1. Non-discretionary LCD change

- Add the new codes to the LCD without changing the clinical indications
- No changes to the coverage criteria
- No notice and comment period

2. Discretionary LCD change

- Published proposed LCD to add or modify clinical indication criteria for catheters
- Notice and comment period will be allowed (45 days)
- Publication of the final LCD

Medicare Urological Local Coverage Determination and Policy Article

Requirements for coverage of catheters:¹

- ✓ Diagnosis of **permanent urinary incontinence or permanent urinary retention must be present**
 - ✓ Permanent impairment of urination
 - ✓ Does not mean there is no possibility that the beneficiary's condition may improve in the future
 - ✓ Condition is of long and indefinite duration

Urological Policy Article Update!²

- The updated language removes the specificity of the 3-month requirement of permanence however it does **not** remove the requirement of permanence
- Language aligns with the [Medicare Benefit Policy Manual](#)³ and the [Medicare Program Integrity Manual](#)⁴

Medicare prescription guidance for hydrophilic catheters

Joint DME MAC publication provides guidance on prescriptions for new hydrophilic intermittent catheter HCPCS codes

- Guidance applies to both Noridian and CGS jurisdictions
- Published July 17, 2025

“Suppliers must discontinue use of A4351, A4352, and A4353 and utilize the new HCPCS codes A4295, A4296, and A4297 on claims for hydrophilic catheters with dates of service on or after January 1, 2026”.

New prescription required

If the existing prescription includes a HCPCS code (A4351, A4352 or A4353), a new prescription is required. The new order can list the new HCPCS codes (A4295, A4296, or A4297), a general description (e.g., hydrophilic catheter), or a brand name / model.

New prescription not required

If the existing prescription is a general description (e.g., hydrophilic catheter), or brand name/model number, a new prescription is not required. Since the verbiage is a description of the new hydrophilic catheter HCPCS code(s), no new order is needed.

Proactively obtain new Standard Written Order(s)

Updating prescriptions now could eliminate the need for new orders on or after January 1, 2026!

1. Identify current hydrophilic catheter users
2. Update order templates
3. Send to clinicians for signature

TIP: Remove the HCPCS code and replace it with the description of the IC:

- ✓ IC type: straight, coude, or closed system
- ✓ Coating type: "hydrophilic" or "non-hydrophilic"

Clinicians can help to ensure catheter users do not experience product access challenges

What can clinicians do?

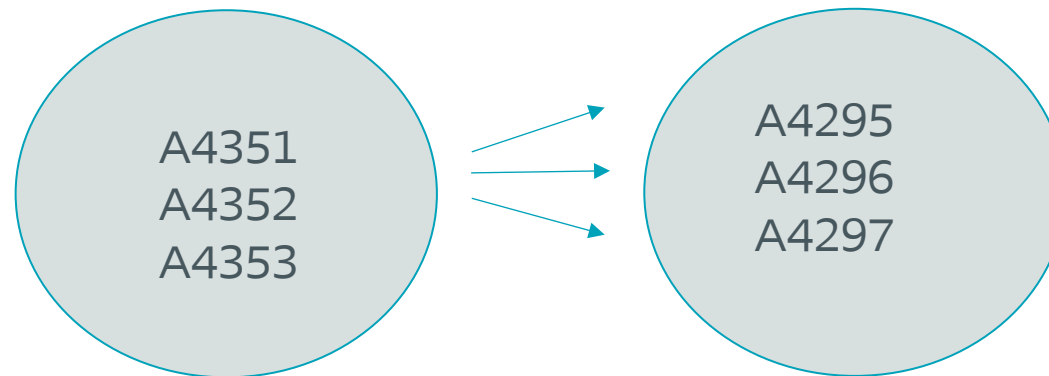
- Prescription renewals - expect requests from DME providers
 - Exclude billing codes, include 'hydrophilic' or brand/item number
- Proactively update prescriptions for hydrophilic catheters
- Initiate conversations with their patients and/or DME providers
- Confirm with case managers as they work closely with DME providers
 - Educate staff on new HCPCS codes



Next steps to prepare for the changes

Utilize the PDAC crosswalk to identify which catheters are changing HCPCS codes

- Crosswalk includes:
 - Manufacturer
 - Product Name
 - Model Number
 - Current HCPCS Code
 - Effective Begin Date
 - HCPCS Code (Effective 1/1/26)

Additional recommendations



- Proactively communicate to your payors
- Monitor payor(s) fee schedule for early adoption
 - Some update 2026 fee schedule in Q4 2025
- Not all payors may adopt the new codes on January 01, 2026, therefore, update price tables or price files accordingly to avoid rejections/denials
 - Check with your software vendor
- Monitor secondary claims to Medicare as claims may cross over and the payor may not recognize the new code
 - January is deductible season
 - Manual cross-walking of the claims may be required until full adoption
 - Claims may pay based on coordination of benefit(s)
- Educate patients on the new code changes
 - Avoid confusion with explanation of benefits (EOB)

Documentation Requirements for New Urological Supplies Codes

Joint DME MAC Publication

Effective for dates of service on or after January 1, 2026, CMS created three new HCPCS codes for hydrophilic catheters:
